

Tahmineh "Tammy" Maloney is General Counsel and Head of Compliance for Katapult, an e-commerce focused fintech company. Tammy previously served as general counsel for E*TRADE Bank and E*TRADE Savings Bank and for a de novo bank in formation.

Before joining E*TRADE

Tammy held positions in the legal departments of the

Federal Deposit Insurance Corporation and the Office of the Comptroller of the Currency and as an associate in Hogan Lovells US LLP's financial services group. Upon graduating law school, Tammy clerked for the Honorable Lawrence M. Baskir, United States Court of Federal Claims. Tammy attended Georgetown University Law Center as a Dean's Scholar and received her undergraduate degree in the Humanities from New College of Florida.

Throughout her career,
Meredith has worked to

financial services industry serves consumers. She joined Plaid from Capital One, where she was a Senior Vice President, Chief Counsel, Regulatory Advisory, leading the firm's enterprise regulatory legal function. Prior to Capital One, Meredith was General Counsel and Acting Deputy Director at the Consumer Financial Protection Bureau (CFPB), after serving as Chief of Staff to CFPB Director Richard Cordray.

Meredith has also held roles as Chief Investigative Counsel of the U.S. House of Representatives Committee on Energy and Commerce, as Vice President and General Counsel at The National Security Archive at GWU, and as a partner at Wiley, Rein & Fielding.

She has served as an officer on the D.C. Bar Board of Governors, and is the recipient of the American Library Association's James Madison Award, and was named to the National Law Journal's list of 75 Outstanding Women Lawyers. She is a graduate of the New York University School of Law and the London School of Economics and Political Science.



Sarah is General Counsel, Chief Compliance Officer, Corporate Secretary, and founding team member at One, a digital banking platform integrating spending, saving, borrowing, and sharing in one account, all accessible with one card.

She also founded and runs the 94104 Exchange, a monthly forum for fintech lawyers and compliance professionals that facilitates "the unregulated exchange of ideas." She joined the board of Anchorage Digital Bank in May 2021.

Before starting One, Sarah was the first GC and CCO at Azlo, a bank-owned tech company providing banking services to small businesses, and the first lawyer and Head of Compliance at Blend, a digital platform providing banking products to banks and lenders. Before her move to San Francisco, Sarah was an attorney at the Office of the Comptroller of the Currency and Buckley law firm, and a Principal at Promontory Financial Group in Washington, DC. She also spent time on Capitol Hill working on House Financial Services Committee issues.

In a prior life, Sarah was an opera coach and played piano, keys, and accordion for operas, musicals, and a cover band.



Katherine Carroll is the Global Head of Policy and Government Affairs at Stripe. Prior to joining Stripe in February 2021, Katherine was a partner in the Financial Institutions Group at Cleary Gottlieb, where she practiced law for nearly two decades.

Her practice focused on advising banking organizations and fintech companies on U.S. bank regulatory matters, cybersecurity and privacy matters, and mergers and acquisitions.

Katherine worked in the U.S. Department of Defense under Presidents Clinton and Obama, most recently serving as Counselor to Secretary of Defense Ash Carter. She advised Secretary Carter on a broad range of issues including cybersecurity and related intelligence matters, the transfer of detainees from Guantanamo Bay, and lifting restrictions on service for transgender service members.

Prior to studying law, Katherine worked as the Executive Director of the Open Society Institute in Uzbekistan. She holds a J.D. from Yale Law School and an A.B. from Harvard College in Russian and Soviet Studies.

Melissa brings 20 years of financial services and fintech policy experience to FS Vector. She joins FS Vector from the US Commodity Futures Trading Commission (CFTC) where she served as the Commission's Chief

Innovation Officer and Director of LabCFTC. While at the CFTC, Melissa worked internally and with fellow regulators on promoting responsible innovation by advancing policy, facilitating dialogue between innovators and regulators and educating stakeholders on the advancements in innovation and technology in the ever-changing financial services industry.

Melissa and her team focused on technology, cybersecurity, small business and financial services policy issues around the globe.
